# Emergency Contingency Plan Development:

### **Emergency Program Review:**

An HRVA is a requirement mandated for municipalities by the Local Authority Emergency Management Regulation of the B.C. Emergency Program Act and represents that starting point for emergency planning within any organization.

3Si has provided this service to a range of clients with the primary focus being to enable critical services and products to be continually delivered to our clients. Instead of focusing on resuming a business after critical operations have ceased or recovering after a disaster, a business continuity plan endeavors to ensure that critical operations continue to be available throughout a crisis without any discernible disruption to critical business unit functions.

# Table Top and Functional Full Scale Emergency Management exercises:

3Si is a recognized industry expert in this area. Tabletop exercises (TTX) are a simple way to test plans and develop the people who will carry those plans out. This process is then used as the backdrop for discussion about actions to be taken and how a plan would be implemented. Functional exercises involve all the components of a tabletop exercise but also include actual responding team members, first responders and associated agencies. Functional exercises allow organizations to validate plans and readiness by creating the conditions that allow staff to perform their duties in a simulated emergency environment. A functional exercise can be limited to organizational staff or designed to be a multi-agency, multi-discipline and potentially a multi-jurisdictional exercise intended to test and evaluate the practical, operational capability of an organization's emergency management system in an interactive manner.
